

GENERAL TERMS AND CONDITIONS OF RENDER OR PHOTO GIVEAWAY CAMPAIGN

“Render or photo challenge by Chaos”

PARTICIPATION IN THE RENDER OR PHOTO CHALLENGE IS FREE AND NO PURCHASE OF GOODS (HARDWARE OR SOFTWARE) OR CONCLUSION OF A SERVICE CONTRACT IS REQUIRED. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING.

I. PRODUCT PRIZE WINNING SOCIAL MEDIA GIVEAWAY CAMPAIGN

The organizer of the giveaway campaign is Chaos Czech a.s., ID 02983842, seated at Karlovo náměstí 288/17, 120 00 Prague, Czech Republic (“*Organizer*”).

The Organizer is part of a corporate group of entities operating worldwide (“*Chaos*”). Chaos consists of the Organizer’s parent company Chaos Software EOOD, a limited liability company incorporated under the laws of the Republic of Bulgaria, registration No. 131375768, Chaos Software GmbH, a limited liability company incorporated under the laws of the Federal Republic of Germany, Amtsgericht Mannheim, HRB 726749, and its Affiliates. For the avoidance of doubt, “Affiliate” should mean an entity that controls, is controlled by, or is under common control with Chaos Software GmbH. For purposes of this defined term, “control” means ownership of more than fifty (50%) percent of the voting stock or other ownership interest in an entity.

The Organizer's decision to hold the RENDER OR PHOTO PRIZE WINNING GIVEAWAY CAMPAIGN (“*Giveaway Campaign*”) under these rules is final and binding on the Organizer.

II. GIVEAWAY CAMPAIGN DURATION

The Giveaway Campaign will be open to participants on 31st October 2024, as further determined by the Organizer.

III. TERRITORIAL SCOPE OF THE GIVEAWAY CAMPAIGN

THIS GIVEAWAY CAMPAIGN IS VOID WHERE PROHIBITED BY APPLICABLE LAWS. THE GIVEAWAY CAMPAIGN IS OPEN TO ANY PARTICIPANTS FROM ALL COUNTRIES WORLDWIDE, EXCEPT FOR RESIDENTS OF EMBARGO COUNTRIES.

In order to receive their awards, the winning participant must contact the Organizer by replying to the e-mail notifying them of their win within 4 (*four*) days after receiving the e-mail from the Organizer and agree with the Organizer on the form of delivering the prize.

If, after the expiration of the aforementioned deadline, the winning participant has not sent a confirmation and has not accepted any of the in-person forms of the prize delivery, they lose their right to receive the prize and the Organizer has the right to withdraw a new winner in their place.

The Organizer reserves the right at all times at its sole discretion to cancel, terminate, modify, or suspend the giveaway campaign and these Terms, in whole or in part, in the event of any cause beyond the reasonable control of the Organizer that interferes with the proper conduct of the giveaway campaign as contemplated by these Terms, including, without limitation, any error, technical problem, computer virus, bugs, tampering, unauthorized intervention, fraud, technical failure, or any other cause.
